## **SECTION 4 - FIRST AID MEASURES**

#### **General Information:**

#### SECTION 5 - FIRE FIGHTING MEASURES

## **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include cotton, rubber. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles.
